2023 Data Access Requests

Heather Pettis reviewed data access requests made to the NARWC in 2023. In total, there were 36 requests to date: 8 management, 22 publication, and 6 others (education, news stories, images)

Data Sharing/Access Working Group

Heather Pettis shared a summary update of the Data Sharing/Access Working Group. The group initially met in June 2022 with three primary points of discussion related to data access and data contributor engagement.

Goals outlined by working group and status:

1. Data Access

- Migrating to more efficient access management system DONE
 - Working group identified platform (Monday.com); working on migration post meeting DONE
- Revising access protocols In Progress
 - o Updates to review of management requests
 - Data requirements for journal publications
 - Clarity around specificity in access request detail

2. Data Contributors

- Better contributor notification In Progress
 - o 800+ contributors
- Tracking point rep for orgs In Progress
 - Need to ensure data can be tracked back to source
- Working group of data contributors and curators In Progress

3. Report Card published

- Setting up DOI and host on WHOI's open access library **DONE**

 - Workshops
 - Definitely keep

 - Suggestions to do two years in the US, 1 in Canada for rotation
 - Suggestions for
 - DC area
 - Raleigh Durham
 - Providence
 - Boston
 - SEUS
 - Concern about a Florida venue in light of multiple groups issuing travel advisories for LGBTQ and minorities in the state.
 - Cost will and should play a role in the decision
 - Need to consider timing and location for increased industry engagement
 - Federal and state participation will likely always be an unknown until late in the game and so need to move forward with planning
